The Upper Occoquan Service Authority (UOSA), the Owner, invites qualified contractors to submit sealed Bids for the project known as "Ozone Biofiltration System," and also by the name "UOSA Contract OBF." Sealed Bids addressed to Mr. John W. Airhart, Director, Capital Improvements, will be received at the office of the Upper Occoquan Service Authority at the date and time given below. The sealed Bids then will be publicly opened and read aloud. The Owner will read only the Lump Sum Bid amount written in words. Any Bid received after the date and time specified will not be considered. The procurement process and the performance of the Contract shall be governed by the provisions of the Virginia Public Procurement Act (VPPA).

The Project includes the construction of a new ozone biofiltration treatment system at the Millard H. Robbins Jr. Regional Water Reclamation Plant (RWRP) at 14631 Compton Road, Centreville, Virginia 20121-2506. The Work includes, but is not limited to, selective demolition of existing facilities at the filter building L/2, construction of a new ozone generation facility, new liquid oxygen storage facilities, an ozone contactor at building L/2, improvements to the intermediate pumpstation, electrical/controls, and sitework/restoration in accordance with the Contract Documents. A complete description of the Work can be found in the Contract Documents.

The Owner will conduct a pre-bid conference and site tour at the date and time given above. All interested Bidders should meet in the Sellman Meeting Center of the UOSA Operations Building (Building G) to participate in the conference and site tour. Bidders are referred to the Instructions to Bidders for information regarding Bidder qualifications. Comments concerning the Technical Specifications or any provisions of the Contract Documents may be submitted either at the pre-bid conference or pursuant to paragraph 1.B (2) of the Instructions to Bidders.

Interested parties may obtain the Bidding Documents from the Owner for \$250.00 per set, which includes the complete set of Contract Documents (reduced-scale drawings). The Bidding Requirements and Contract Documents are as defined in the General Conditions. All provisions of the Contract Documents applicable to this procurement are incorporated herein. Full scale, or additional reduced-scale Drawings are available for \$150.00 per set from UOSA. The Bidding Documents may be purchased on or after October 11, 2023 from the office of the Owner, UOSA. Interested Bidders should contact the UOSA Capital Improvements Division at (703) 227-0292 to make arrangements to purchase Bidding Documents. To purchase the Bidding Documents or Drawings, parties should make their check or money order payable to "Upper Occoquan Service Authority." Return of the Bidding Documents is not required, and the amount paid is non-refundable.

A copy of the subsurface utility test-hole reports and geotechnical report are included free of charge with the Bidding Documents. These reports are for the Bidder's information only and are not a Contract Document. The Owner makes no representations, warranties or guaranties regarding the accuracy or completeness of any information contained in the

reports. Bidders are referred to the Instructions to Bidders for further information regarding use of these reports in the preparation of Bids, as these reports are considered Site and Existing Facilities Information as addressed in the Instructions to Bidders.

Only Official Bidding Document Holders (those who obtain from the Owner a complete set of Bidding Documents) will receive addenda and only Official Bidding Document Holders may submit a Bid.

The Bidding Documents may be examined at the office of the Owner at the address listed above. Please call (703) 227-0292 to coordinate such examination. The requirements for Bid Bond, Payment Bond, and Performance Bond are included in the Instructions to Bidders. To perform public work in the Commonwealth of Virginia, Bidders shall hold such Contractors' and Business Licenses as required by State law and local ordinances. Bidders are required to be licensed contractors in the Commonwealth of Virginia in compliance with Title 54.1, Chapter 11, of the Virginia Code. The Bidder shall provide with its Bid evidence of compliance with these licensing requirements as a condition of the Bid being considered. In addition to compliance with all licensing requirements, the Bidder shall have in effect and shall provide with its Bid a Federal Employer Identification Number. Bidders are referred to the Instructions to Bidders for other qualification requirements for Bidders.

Prior to Contract award for the Work contemplated by the Contract Documents, the Owner will conduct such investigation as the Owner deems appropriate to determine the performance record and ability of the apparent lowest Bidders as the Owner deems appropriate to perform the size and type of Work specified under the Contract. Upon request, each Bidder shall submit such information as is deemed necessary by the Owner to evaluate the Bidder's qualifications. Failure to submit information deemed necessary by the Owner shall make the Bid non-responsive and the Owner at its sole discretion may reject the Bid.

The attention of Bidders is directed to the applicable Commonwealth of Virginia requirements and conditions of employment to be observed under the Contract. Each Bidder shall inform itself of, and the Bidder awarded the Contract shall comply with, all Federal, State, and local laws, statutes, ordinances, and regulations relative to the execution of the Work. These requirements include, but are not limited to, applicable regulations concerning minimum wage rates, nondiscrimination in the employment of labor, protection of natural resources, fire protection, safety, permits, taxes, fees, and similar subjects.

Within the aforementioned time after the opening of Bids, the Owner will issue written Notice of Award or Notice of Intent to Award or will act otherwise in accordance with the following paragraphs. Notice of Award shall be mailed to the successful Bidder at the office address given on the Bid Form and Notice thereof to others shall be by posting in the lobby of the Owner's Administration Building and on the Owner's webpage. In the event of failure of the lowest responsive, responsible Bidder to sign the Contract and provide acceptable insurance certificate(s) and, if required, Performance Bond and Payment Bond, the Owner may award the Contract to the next lowest responsive, responsible Bidder.

The rights are reserved by the Owner to (i) reject all Bids; (ii) reject any Bid not conforming in all material respects to the Invitation to Bid and to the intent and purpose of the Contract Documents; and (iii) waive informalities and irregularities in any Bid.

The right also is reserved by the Owner to negotiate with the responsible Bidder submitting the lowest responsive Bid in the event such Bid exceeds the Owner's budget for the Work. Such negotiations, if the Owner elects to negotiate rather than reject all Bids, shall be directly between the Owner and such Bidder. The Owner and such Bidder shall review the Contract Documents, and the Owner may provide such additional information as it deems appropriate to provide. Such Bidder then may be invited by the Owner to submit a revised Bid. Such Bidder shall be under no obligation to submit a revised Bid and the Owner may reject any such revised Bid.
