#### **Questions and Answers**

1. **Q:** Are equipment rental rates required at the time of submitting the bid?

**A:** Rates for Contractor owned equipment rentals are required with the bid if applicable. If Contractor owned equipment rental is not offered, then Section C of the Bid Pricing Schedule can be marked as N/A. The markup for rental equipment rented by Contractor from third party is required in Section D of the Bid Pricing Schedule.

2. **Q:** Could the same reference/past performance project(s) be used for different areas in Attachment E – assuming they included the referenced scope?

**A:** Yes, it is acceptable to provide the same reference for multiple task areas as long as the specific portion of the project reference that applies to that task area is indicated in the project description.

3. **Q:** Is there a Davis-Bacon wage or other wage-scale requirement project?

A: No

4. **Q:** Please confirm that change orders are to be considered on a case-by-case basis by the prevailing contractor.

**A:** Change orders will be administered in accordance with the Terms and Conditions provided as Attachment A to the solicitation.

5. **Q:** Does the bid submission need to be in hard copy, or can we submit through eVA portal? If hard copy is required, can it be hand delivered and if so to what address?
